Expertise, Resources and Services

CDIC offers expertise in both *deposit insurance* and *failed bank resolutions*. The CDIC mandate is relatively broad and approaches that of a full-scale risk minimizer. CDIC experts can share experiences in deposit insurance system design, implementation, operation and transition, including risk management and risk-based premiums. CDIC experts can also speak on the topic of purchase and assumption methods.

CDIC offers *professional training* in the form of classes, courses and workshops based on the requested subjects, but CDIC doesn't offer regular or irregular fixed program classes. CDIC additionally offers speakers and presentations at meetings, seminars and workshops co-hosted or hosted by other deposit insurers. Expert consultation services are not available.

Individual training programs arranged by CDIC can be scheduled optimally for 2-3 days in duration, and preferably with at least 60 days advance notice, subject to the availability of necessary resources.
